Al. Neyer Gets Work Underway for Intelligrated Expansion in London, Ohio

Intelligrated repeatedly chooses Al. Neyer

CINCINNATI – Cincinnati-based developer Al. Neyer announced today it has secured and begun work on a \$3.4 million project for <u>Intelligrated</u>, the Mason, Ohio-based automated material handling solutions provider that has seen continued growth since its founding in 2001.

Intelligrated selected Al. Never to design and construct a 75,000-square-foot manufacturing addition to its existing warehouse in London, Ohio, about 25 miles southwest of Columbus. The expansion to Intelligrated's current 209,000-square-foot manufacturing facility was needed to accommodate the company's growth.

"The new building will help us continue to expand our footprint and provide the absolute best in automated material handling solutions," said Chris Cole, CEO, Intelligrated. "Given our solid history with Al. Neyer, the decision to work with them again was obvious."

Within the past decade, Intelligrated has repeatedly chosen Al. Never for its design, construction and renovation needs. The ongoing relationship factored heavily into the decision to again team with Al. Never for the most recent round of improvements. Although Gately Enterprises – which owns Intelligrated's London facility – considered several firms for the work, the company ultimately moved forward with Al. Never at Intelligrated's recommendation.

The expansion is the fourth project Al. Never has worked on with Intelligrated. In 2002, Al. Never designed and built the company's 140,000-square-foot headquarters. That same year, Al. Never provided tenant improvements to its London, Ohio warehouse, a space that Intelligrated acquired in a merger.

More recently, Intelligrated chose Al. Never to build an addition to its Mason headquarters. In January 2013, Intelligrated celebrated the grand opening of its 122,000-square-foot expansion, giving its headquarters a combined area of 262,000 square feet for its daily operations.

"Over the years, we've seen Intelligrated grow leaps and bounds, and we've been able to provide them with new or renovated space tailored specifically to facilitate their continued growth," said Dave Neyer, executive vice president, Al. Neyer.
